From April 16-18, the G7 Foreign Ministers' Meeting was held in Karuizawa, Nagano Prefecture. On April 16, FM Hayashi hosted a working dinner on the Indo-Pacific. change the status quo by force, as well as to strengthen engagement with the countries known as the "Global South."

Minister Hayashi expressed Japan's intention, during the year of its G7 Presidency, to demonstrate the importance of a free

and open international order based on the rule of law and the G7's strong determination not to accept unilateral attempts to Following this, Minister Hayashi, as the representative of the only G7 member from Asia, explained recent developments in the Indo-Pacific, among other matters, and held an open exchange of views with the other G7 Foreign Ministers on various challenges in the Indo-Pacific region, including China and North Korea, and the G7 Foreign Ministers shared the view that the unity of the G7 is extremely important to this end. Regarding North Korea, Minister Hayashi expressed grave concern over North Korea's launch of ballistic missiles with an unprecedented frequency and in unprecedented manners, including the launch in the previous week, and the G7 Foreign Ministers strongly condemned North Korea's repeated launches of ballistic missiles. Furthermore, the G7 Foreign Ministers once again expressed their support for the immediate resolution of the abductions issue.

The G7 Foreign Ministers also continued to discuss matters such as regional affairs, including the Indo-Pacific, on April 17. Other sessions were held on topics such as <u>Ukraine</u>, and <u>Cooperation with International Partners</u>, among others. FM Hayashi also held bilateral meetings with his counterparts from the United States, the UK, Italy, and Germany. See a full overview of the G7 Foreign Ministers' meeting here.

2. Foreign Minister Hayashi Visits China - (April 1-2, 2023)

(Photo: Ministry of Foreign Affairs) Japan-China Foreign Ministers' Meeting and Working Lunch From 10:30 on April 2 local time, during his visit to Beijing in the People's Republic of China, Foreign Minister Hayashi held a Japan-China Foreign Ministers' Meeting and a working lunch with H.E. Mr. Qin Gang, State Councilor and Minister of Foreign Affairs of the People's Republic of China. At the outset, Minister Hayashi, referring to the meeting between Prime Minister Kishida and President Xi Jinping in November 2022 where the two leaders affirmed the building of a "constructive and stable Japan-China relationship," stated that while Japan and China share various possibilities, they face many challenges and serious concerns, and that they are

now standing at a critical juncture. He also pointed out that both countries have immense responsibilities for the peace and prosperity of the region as well as the international community, and that he hoped that both sides will continue making efforts to put the common understanding shared by the two leaders into practice. Minister Qin indicated that he was of the same

Minister Hayashi made a protest regarding the recent incident of the detention of a Japanese national in Beijing and

strongly reiterated Japan's resolute position on this matter, including the Japanese national's swift release.

The two ministers reaffirmed the importance of maintaining communication, including in security-related areas. Minister Hayashi referred to Prime Minister Kishida's recent visit to Ukraine, and called on China to play a responsible role in maintaining international peace and security. The two ministers also exchanged views on the regional situation, such as the response to North Korea including the abductions issue, the nuclear and missile programs, cooperation in the forum of the

Minister Hayashi reiterated Japan's serious concerns about matters such as the situation in the East China Sea, including

Foreign Minister Hayashi Pays a Courtesy Call on State Council Premier Li Qiang From 16:00 pm on April 2 local time, FM Hayashi paid a courtesy call on H.E. Mr. Li Qiang, Premier of the State Council of the People's Republic of China. Minister Hayashi stated that it is important that both governments support the economic and people-to-people exchanges, and pointed out that it is extremely important for the Chinese government to ensure an environment in which Japanese nationals and Japanese companies can conduct activities with a sense of security in China.

Both sides concurred on the importance of continuing close communication at all levels, including at the high level.

On March 23, FM Hayashi held a meeting with H.E. Mr. KWON Youngse, Minister of Unification of the Republic of Korea, who is visiting Japan upon invitation by the Ministry of Foreign Affairs of Japan. The overview of the meeting is as follows. At the outset, Minister Hayashi appreciated the visit of H.E. Mr. YOON Suk Yeol, President of the Republic of Korea, to Japan last week and stated that the two leaders had a fruitful discussion and concurred to facilitate smooth communication between the two governments, and that he was pleased to meet with Minister Kwon right after the President's visit to Japan. The two Ministers also exchanged views on North Korea and shared a recognition that North Korea's ballistic missiles launches with an unprecedented frequency and in unprecedented manners not only constitute a grave and imminent threat to

The two Ministers affirmed that they would continue to coordinate in dealing with North Korea, including on the nuclear and missile issues. In addition, Minister Hayashi asked for continued understanding and cooperation for the immediate resolution

On April 12th, FM Hayashi held the telephone talk with H.E. Dr. Hossein Amir Abdollahian, Minister of Foreign Affairs of the

The Ministers also exchanged views on the situation in Ukraine and agreed on continuing bilateral dialogue in a wide range

On March 28th local time, the "Agreement between the Government of Japan and the Government of the United States on Strengthening Critical Minerals Supply Chains" (Japan-U.S. Critical Minerals Agreement (CMA)) was signed at the office of the USTR in Washington, D.C., between Ambassador Tomita Koji, and the Honorable Katherine Tai, U.S. Trade Representative.

Facing the prospect of significant increase in demand of electric vehicle batteries, it is urgent to secure critical minerals which are essential to the production of clean vehicles. The Agreement is envisaged to build robust supply chains through coordination between Japan and the U.S. and among like-minded countries with strengthened cooperation for ensuring sustainable and equitable supply chains for such critical minerals, including to promote the goals of the Inflation Reduction

At the outset, Foreign Minister Hayashi stated that he was pleased to hold the third telephone talk with Foreign Minister Amir-Abdollahian. In response, Foreign Minister Amir Abdollahian expressed Iran's intention to further deepen the relationship between Japan and Iran, which has a long established history. The Ministers exchanged candid views on the latest developments surrounding Iran's nuclear issue. Foreign Minister Hayashi stated that Japan has consistently supported the Joint Comprehensive Plan of Action (JCPOA) and expressed his strong hopes for a constructive response from Iran, including the full and unconditional cooperation with the International

Atomic Energy Agency (IAEA). Further, the Ministers decided to continue close communication on this matter.
