

TEMPORARY VISIT FOR CHINESE CITIZENS (MULTIPLE ENTRY)

【Definition】 Chinese citizens traveling to Japan for tourism, business affairs, commerce, conferences, visiting relatives/acquaintances as a temporary visitor. Performing activities to undertake revenue generating business operations or activities to receive remuneration are NOT permitted under this visa.

【Term of Stay】 Stay up to 30 or 90 days

【Validity of Visa】 Multiple-entry: 3 or 5 years from date of issue

*The applicant may be required to submit additional documents, if needed. It is recommended that applicants also submit flight schedules and itinerary (with the information of the accommodation clearly filled out OR submit proof of ticket/reservation confirmation). Applicants may still receive a single-entry visa. **There is no guarantee that the applicant can obtain a multiple-entry Visa.**

【Note】

- A multiple-entry visa will not be issued if the applicant does not have sufficient financial means. When applying for a visa with the assets of a guarantor, applicant can only apply for a single-entry visa.
- Dependents can apply for a multiple-entry visa if their spouse or parent already holds a valid multiple-entry visa.
- If applicant does not possess a valid U.S. visa sticker, most visa applications will be denied.
- It is not required to purchase an airline ticket before applying for a visa. Applicants should fill in the flight and hotel information that best reflects their travel plans on their application.

REQUIREMENTS:

VALID PASSPORT: Properly signed by bearer. Must have at least one blank VISA page

PROOF OF YOUR U.S. IMMIGRATION STATUS:

Copy of Valid U.S. Permanent Resident Card (Green card)

Copy of Valid U.S. Visa (if necessary, AND copy of I-797)

(If you have a Valid F1 Visa, MUST submit I-20 with valid travel endorsement signature, (if applicable, EAD card) along with F1 Visa)

(If you have a Valid J1 Visa, MUST submit DS-2019 with valid travel endorsement signature along with J1 Visa)

COMPLETED VISA APPLICATION FORM:

([Visa Application Form](#)): The applicant must complete the visa application form in black pen or typed. Signature must be original.

On the application form, if there is a field not applicable, please write “N/A” or “None” and DO NOT leave a section blank. [Please reference this sample form when filling out the application.](#)

ONE PASSPORT SIZE PHOTOGRAPH:

2 X 1.4 inch photograph with a plain background taken within the last six months.

[REQUEST FOR A MULTIPLE-ENTRY VISA:](#)

Applicant must complete this form and indicate the categories (1-6) they fall into, the reason they require a multiple-entry visa, and their future plans for visiting Japan.

A DOCUMENT WHICH PROVES that the applicant has sufficient financial capability:

Both of the following are preferred;

Latest pay slip with YTD income, W-2 form, etc.

Bank Statement for the past 6 months

Bank statement must be issued by a bank in the U.S. under applicant's name and current address. If applicant has multiple bank accounts, they may submit all of them. If the bank statement is in the applicant's spouse or parent's name, applicant must also submit a Marriage Certificate or Birth Certificate.

VISA FEE \$44 AND **[Visa Fee Payment Form](#)**

Multiple-entry visa fee is \$44.00 USD (CASH ONLY: credit cards or personal checks are not accepted).
